RAMS will not be liable for any costs of removal, installation, transportation or any other charges which may arise in connection with a warranty claim. ## **Warranty Instructions:**

2. RAMS will give instruction for returning the machine.
3. All items must be sent freight prepaid. Documentation that must be included is the serial number and proof of purchase with purchase date.
4. When RAMS receives the machine, it will be determined whether or not it is covered under the warranty.
  - a. Providing the problem is covered under warranty, the machine will be repaired at no charge and all freight costs will be reimbursed.
  - b. If it is not covered, RAMS will provide a quote and require a Purchase Order to complete the work and ship machine back to customer.
